****FINGER LAKES COMMUNITY PRESERVATION ACT
OF 2019* ASSEMBLY BILL A5029A SENATE BILL
S2270A***

Dear Peter,

The New York State legislature just unanimously passed a bill that would block the construction of a garbage burning incinerator in the heart of the Finger Lakes in Romulus, NY.

It is urgent that you call and email Governor Cuomo to ask him to sign the bill into law!

Governor Andrew Cuomo has already [stated publicly](#) his opposition to the incinerator proposed for the former Seneca Army Depot in the Town of Romulus saying that the, “incinerator project is not consistent with my administration's goals for protecting our public health, our environment, and our thriving agriculture-based economy in the Finger Lakes.”

It is imperative that he sign this bill into law, protecting the Finger Lakes region from
